Weekly Influenza Surveillance Summary

WEEK 46: Nov 13 – Nov 19, 2022

November 28, 2022

Overview

Influenza surveillance for Kane County Health Department includes the collection of data from hospital emergency rooms, laboratories, and public schools. Our participants have reported the following aggregate measures:

- Among four reporting hospital emergency rooms, 19.5% of visits were for influenza-like illness (ILI).¹
- During Week 46, 4 labs reported that 367 of 1250 (29.4%) specimens tested for influenza were positive.²
- **We hope to start reporting on school absenteeism for influenza-like illness shortly
- As of the week ending November 19, there have been 10 influenza-related ICU admissions reported to the health department.
- To date, 1 outbreak of influenza have been reported in Long-Term Care/Assisted Living facilities in Kane County.

Emergency Room Visits

During Week 46, 19.5% of reported hospital emergency room visits were for influenza-like illness (ILI).¹

Each week, data for the 2022-23 season will be presented with data from the previous flu seasons to show the trend of ER visits for ILI over time.

Visits for influenza-like illness to reporting emergency rooms during Week 46 had the following age distribution:

- 0-4 years: 22.8% of all ILI visits
- 5-24 years: 44.7% of all ILI visits
- 25-64 years: 23.9% of all ILI visits
- 65+ years: 8.6% of all ILI visits


Throughout the season, KCHD will provide updated information on the total number of people visiting the emergency room for ILI, and what age groups make up those visits.


% of Emergency Room Visits for Influenza-Like Illness

Participating Emergency Rooms: N=4






Student Absenteeism

*As of the time of this report preparation, week 45 has not been updated on the CDC flu activity map

- No Activity:** No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.
- Sporadic:** Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.
- Local:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.
- Regional:** Outbreaks of influenza or increases in ILI and recent laboratory confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.
- Widespread:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.
